This location is a hub for cultural and artistic events in Alexandria, and will provide March150 artists and visitors with a larger space to display and view the art.

Artists pick up unsold artwork and buyers pick up purchased artwork from Torpedo Factory Art Center between 10:30 a.m.– 5:00 p.m..

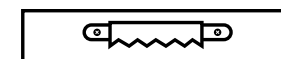
GUIDELINES

There are no limitations on artwork style, theme, or medium except for the following rules listed below. Any artwork that violates these rules will not be accepted into the exhibition.

1. All work must be produced on the 10" x 10" wood panels sold by the Art Center.
2. All artwork must have an Artist Agreement filled out and attached to it upon drop-off. (Agreements are attached to this document).
3. All artwork must be hung/displayed as a square (no diamond please).



4. Artwork may not protrude off the sides of the panel. All must fit within the 10" x 10" space provided.
5. Artwork may not protrude more than 3" off the front of the panel (for sculptural/mixed media) - it must be able to fit inside a large USPS Priority Box.
6. Artwork deemed to be unsafe to the public by staff will not be exhibited.
7. **Only if you flip/invert the panel and create artwork using the back**—you are required to install a sawtooth hanger yourself. The gallery will not install them. **Everyone making work on the front of the panel is NOT required to provide hardware.**



8. All artwork submitted must be dry/complete.

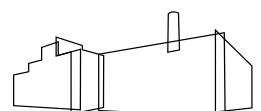
